Crystal argues that this shift is not a degradation but a natural evolution of language in response to new

Naomi Baron, a professor of linguistics and expert in digital communication, explores how mobile and online technologies have altered our expectations around language formality. She asserts that the rise of texting, instant messaging, and social media has fostered a “whatever” attitude toward formal writing. According to Baron, this relaxed approach reflects broader cultural shifts rather than technological causation alone. She warns that while digital media offers new expressive possibilities, it also complicates the enforcement of traditional norms in educational and professional contexts [4]. Language norms—rules governing grammar, usage, and style—have long served as the backbone of effective communication. Traditionally, these norms were shaped by academic institutions, literary standards, and prescriptive grammarians. They provided consistency across written and spoken forms, helping societies maintain clarity and mutual understanding. However, in the modern era, these norms are increasingly challenged by rapid technological change, shifting cultural values, and evolving modes of communication.

John McWhorter, a linguist at Columbia University, critiques both traditional and modern forms of prescriptivism. He opines that while older grammar rules were often arbitrary, today's sociopolitical pressures have introduced a new kind of linguistic policing—particularly around identity labels and inclusive language. McWhorter argues that this “woke prescriptivism,” though well-intentioned, can stifle organic linguistic development and create confusion around usage. He emphasizes the importance of descriptivism, which seeks to understand how language is actually used rather than how it should be used [5]. Deborah Cameron, a feminist linguist, focuses on how language norms intersect with gender and power. She opines that traditional norms often reflect patriarchal values, reinforcing male dominance in discourse. Cameron highlights modern problems such as misogynistic language online and the persistence of gendered stereotypes in everyday speech. She argues that challenging these norms is essential for achieving linguistic equity and social justice.

In short, language norms are faced with profound current challenges due to globalization, online communication, social transformation, and standardization controversies. The tension between being clear and tolerant of linguistic variety is the hallmark of current linguistic problems. To fend off these intricacies, societies must build an advanced understanding of language as a set of rules and a vibrant dynamic mode of human contact [6]. Ultimately, embracing a flexible approach to the norms of language—one that respects convention but is willing to innovate—will better accommodate multicultural, transnational communities and preserve language as a dynamic, extensible means of communication in the present world [7].
