In particular, the Republican Center of International Culture (1992), the Republican National Idea and Ideology Center (1996), the Republican Center for Spiritual Promotion (1998), the Coordination Council for the Development of National Culture under the Ministry of Culture and Sports Affairs (1997), under the Cabinet of Ministers of the Republic of Uzbekistan Committee on international relations and friendly relations with foreign countries (2017) was established. Developing a culture of tolerance and humanitarianism, strengthening inter-ethnic harmony, civil harmony in society, creating equal rights and opportunities for all citizens regardless of their nationality and religious beliefs, educating the young generation in the spirit of patriotism, respect for national and universal values, love and loyalty to the Motherland is an important priority of the state policy in Uzbekistan. is designated as one of the directions.

The diversity of the population living in Uzbekistan is considered as a favorable factor of socio-economic development. By ensuring social and economic stability, harmonizing inter-ethnic relations, Uzbekistan's position in the international arena is constantly increasing. About 7 billion 700 million people, who speak 7000 languages and dialects, live in about two hundred countries on earth. If we pay attention to the ethnic map of the world, we can see that there are about 2,000 different nationalities and peoples living in the world today, ranging from a few hundred to several hundred million. Therefore, inter-ethnic tolerance, mutual respect and friendly relations between them will remain the main factor of ensuring stability and peace in the world.

In particular, education in state educational institutions in our country is conducted in seven languages. The programs of the National Television and Radio Company of Uzbekistan are shown in twelve languages, and newspapers and magazines are published in more than ten languages. 138 national cultural centers, as well as about 2,300 religious organizations belonging to 16 denominations, operate under the committee of international relations and friendly relations with foreign countries.

In the field of international relations, scientific, including social studies, as well as monitoring of the development of processes in this direction are being carried out on a systematic basis.

In 2017-2021, the President's decree on the implementation of the development strategy in the five priority directions of the development of the Republic of Uzbekistan in the "Year of Science, Enlightenment and Digital Economy Development" stipulates the development of the concept of development of the field of science until 2030.

In this regard, on October 29, 2020, the President's decree "On approval of the concept of development of science until 2030" was adopted.

It is worth noting that this decree provides for rapid development of economic sectors and the social sphere, wide use of scientific-innovative potential with full mobilization of scientific-intellectual and financial resources, setting priorities for regular reform of science in the future, modern knowledge and independent thinking training of highly qualified personnel is important as it serves to raise the work of modernization of scientific infrastructure to a new level in terms of quality.

Within the framework of its activities, this committee consistently and effectively implements the state policy on ensuring inter-ethnic harmony and tolerance in the society and cooperates with 150 national cultural centers.

In order to further increase the level of cooperation between state bodies and civil society institutions in the field of inter-ethnic relations, on November 15, 2019, the decree of the head of our state "On approval of the concept of the state policy of the Republic of Uzbekistan in the field of inter-ethnic relations" was adopted. Based on this document, the concept of the state policy of the Republic of Uzbekistan in the field of international relations was approved. In order to strengthen public control over the activities of state bodies responsible for the implementation of state policy in this area, a parliamentary and public control mechanism was also established. Also, a public council was established under the committee in accordance with the decision of the Cabinet of Ministers on December 25, 2017, in order to strengthen public control over the activities of state bodies responsible for the implementation of state policy in the field of inter-ethnic relations.
