Because activists, elders who have seen a lot, our experienced intellectuals, if they want, are able to solve any problem in cooperation with the public, and guide the young people who have made a mistake." indicates responsibility.

A number of decrees and decisions on the reform of the neighborhood system have been adopted by our government and are being put into practice. In particular, 2022 will be declared the year of "Glorification of human value and active neighborhood", "The priorities of the state policy on the development of entrepreneurship in the neighborhood, ensuring employment of the population and reducing poverty are correct. Presidential decree on" 1, measures to fundamentally improve the system of working with youth in the neighborhood on" 2 presidential decree, "On measures to improve the system of working with family and

RESULTS

This year, the positions of assistant mayor, youth leader, and women's activist were introduced. Appropriate monthly salaries have been set for each position. The tasks to be performed by the new post holders in the neighborhoods were defined.

The following are the main duties and activities of the assistant governor.

1. "household" study of socio-economic activity in the neighborhood
2. By studying the interests of unemployed people who do not have regular income, especially young people and women, directing them to vocational and entrepreneurship training centers and helping to ensure the employment of graduates to give
3. Development of family entrepreneurship of residents of the neighborhood
4. Effective organization of the use of residential plots
5. By determining the available vacancies in the neighborhood and the demand of economic entities for seasonal workers, first of all, the unemployed

Placement of young people and women included in the "iron register" and "youth register" in vacant jobs and involvement in paid public works¹

The following are the main responsibilities of a neighborhood youth leader.

1. Forming the youth balance sheet, entering the necessary information about young people into the "Youth Register" and "Youth Portal" electronic platforms, organizing effective work with them
2. Meaningful organization of free time of young people in the neighborhood
3. To increase the social activity of young people, to encourage their talent, talents and initiatives, and to help them find their place in life.
4. Education of young people in the spirit of patriotism and their intellectual development
5. Systematic work with young people with a tendency to commit crimes, support for social and pedagogical rehabilitation and adaptation of young people released from penal institutions, returning from specialized educational institutions²

The main tasks of women and girls activists in the neighborhood are as follows.

1. Social and legal support of women and girls in neighborhoods and labor teams, increasing their social and political activity, improving their spirituality, preparing young people for family life, forming a modern model family, improving its spiritual and moral environment and traditions. implementation of targeted measures to strengthen traditional family values;
2. Cooperation with the district governor's assistant on the development of entrepreneurship in the neighborhood, ensuring employment of the

population and reducing poverty, on the implementation of business ideas of women and girls, attracting loans, subsidies and other support measures to their activities;

3. In cooperation with "Women's Advisory Councils", training women in need of social protection in entrepreneurship, developing model business plans and assisting them in obtaining loans, carrying out targeted work with women included in the "Women's Register";

4. Carrying out address work with women included in the "Women's register";

5. Identifying the problems of women in a timely manner, carrying out work with women and girls who have fallen into a difficult social situation, including women with disabilities, individually and with a specific goal, to help them with socio-legal, psychological and material organization of relief work 1

In addition, working with low-income women in the neighborhoods who lost their breadwinners was defined as one of the main tasks of the women's activist position. Women's activists also carry out practical work on identifying the problems of unemployed women who have the need and desire to learn social, economic, legal, psychological, support, knowledge and profession, and include them in the "Women's Register". . Creates and monitors the database on "Women's Notebook".

DISCUSSION

It is an important social object in guiding the youth of the neighborhood to science and profession, providing employment to the unemployed and assisting in employment. Solving the problems of the population, developing entrepreneurship, fundamentally improving the system of working with young people,
