The work of an ambassador consists entirely of words, and if his words are good, he will find his desire.

It is known that in ancient times in the East the art of speaking was called preaching. The word "preaching" is translated from Arabic as exhortation. The word "preaching" means a preacher and a speaker. The famous writer Alisher Navoi writes about oratory in his work "Mahbub ul-qulub": "Propaganda is the work of the one who is alert and receptive to his exhortation. The preacher should be such that if someone enters the meeting empty, he should leave full; Those who enter full should retreat a little and return relaxed. If the preacher is a scholar and an honest worker, then those who deviate from his exhortation will be sinners" [4]. These historical examples show that effective and persuasive speech has always been important in politics and social relations.

In today's world, powerful political speeches play a significant role in shaping public opinion and guiding society. Powerful speeches by world leaders, political candidates, or activists have the power to mobilize, inspire, and unite people toward a common goal. As Russian writer V.A.
