# Practical techniques for developing reasoning and argumentation

1 Analysing a text and highlighting arguments

Working with fiction, journalistic and popular science texts gives pupils the ability to identify the author's position, notice the arguments used and assess their persuasiveness. It is useful to draw up a table "thesis - arguments - conclusion".

## 2. Problem posing

The teacher asks open-ended questions: "Why does the author think this way?", "What arguments support his opinion?", "Do you agree with his position?". Such tasks stimulate analytical activity and encourage pupils to formulate their own answer.[3]

# 3. Composition of written reasoning

Exercises for writing small essays on topical subjects ("Does a person need friendship?", "Is it possible to live without books?") form the ability to build a logical text and use examples from literature, history and personal experience.

#### 4. Discussion and debate

Organising discussions in class promotes the

#### 5. Rhetorical exercises

- -identify strong and weak arguments in someone else's text;
- -reorganise the reasoning, strengthening the evidence.[4]

#### 6. Creative tasks

Essays, reviews, and oral presentations provide opportunities to apply argumentation skills in various speech genres.

Speech activity is an essential component of the learning process, as it is through speech that knowledge is acquired, concepts are formed, and thinking is developed. Modern schools focus on developing not only language skills in students, but also their ability to express their thoughts clearly, logically, and persuasively. The central figure in this process is the teacher, who creates conditions for the development of students' speech, guides their communicative activity, and corrects it.

# Key aspects of the role of a teacher

1. The teacher as an organiser of speech practice

For the successful development of speech skills, students need to be internally motivated. The teacher stimulates interest through relevant topics for discussion, the inclusion of real-life situations, and creative tasks (essays, projects, oral presentations).

5. The teacher as a communication partner

In the dialogue model of teaching, the teacher acts not only as a supervisor, but also as an equal participant in communication. This creates an atmosphere of trust and encourages the free expression of thoughts.

#### The role of the teacher

A Russian language teacher acts not only as a source of knowledge, but also as an organiser of speech practice, creating conditions for the free and meaningful expression of students' thoughts. Their task is to motivate students to independently search for arguments, correct their reasoning, and demonstrate examples of logically structured speech.
